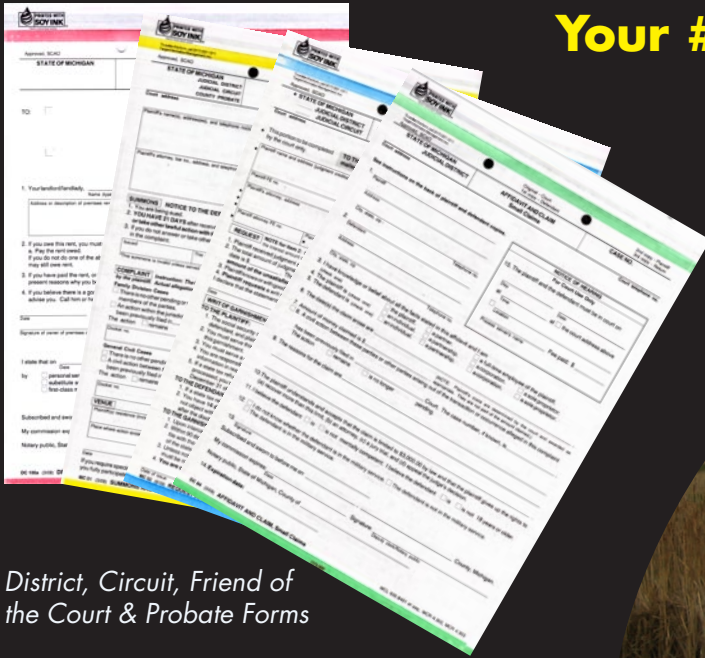

This is coated front and back or what is called CFB so that the back side of each sheet will image onto the face of the next sheet. These are sold in reams of 500, or in cartons of 10 reams (except Giroform, sold 5 reams to a carton). Prices are per thousand (m) sheets.

Prices are volatile on paper and may change but current prices are shown below. We offer four types. We offer three laser grade papers and one designed for offset printing that is popular none-the-less. (see details at right)

Helpful Information

Image quality decreases as the number of sheets in a set increases. Lighter weight paper (about 20 pound - made for offset printing presses) images slightly better through many sheets than heavier weights. "Laser" paper is heavier weight (about 23 pound) but is specifically designed for laser printers and copiers and accordingly is also more expensive. The laser paper is supposed to run better with less jamming or curling in digital devices and is guaranteed not to damage rubber rollers in these devices. Still some people prefer the less expensive and thinner paper for offset printing. For context, standard copier paper is 20 pound and our multiple part forms are made with about 15 pound paper (for better imaging).

8 1/2" x 11" Snap Carbonless or Carbon Forms

Prices are the same for self imaging carbonless forms or for carbon forms. Most forms are carbonless but the most popular forms are available both ways.
